Student Health Return for Service Bursary Program
Information Sheet for Applicants

BURSARY PROGRAM

The purpose of the Bursary program is to recruit and retain needed health care professionals to meet the needs of the people of Northern Saskatchewan. The Health Bursary is offered to students in a variety of health disciplines. In return for this assistance, a bursary recipient must commit to work in our Region.

ELIGIBILITY

To be eligible to apply for this student health return service bursary, you must:

- Be a Saskatchewan resident
- Be accepted and enrolled full time in an approved educational program.

BURSARY AMOUNT

\$1,000 one-time payment for a one year program.

RETURN SERVICE REQUIREMENT

Bursaries are awarded to individuals who sign a contract agreeing to, upon graduation, provide a specific period of service in an approved publicly funded position in Saskatchewan. In return for bursary assistance, bursary recipients are required to work full-time for:

one (1) year of fulltime work or 1948.8 hours.

**Failure to provide the return service means bursary funds must be repaid, including interest, at the rate stipulated in the bursary agreement.

APPLICATION PROCESS

The following documentation must be submitted to the Human Resources Department (address below):

1. A completed application form
2. Documentation from education program indicating that student has been accepted or is currently enrolled in the program.
3. Brief explanation of future plans, experiences and why interested in a career in health care.

SELECTION PROCESS

Bursaries are awarded through a selection process. Not all applicants are awarded a bursary. Applicant may be screened, interviewed and selected based on criteria such as the following:

- Preference will be given to applicants with the greatest likelihood of staying in northern Saskatchewan
- Preference will be given to applicants who self-declare that they are of aboriginal ancestry
- Preference will be given to applicants who are from northern Saskatchewan
- In hard to recruit or other disciplines based on need, as determined by the Transition Lead-La Ronge.

NOTE: If we are unable to contact you, your application will not be entered into the selection process.
